## **New Book from Leading Activist Makes Case for Constitutional Amendments to Protect Environment**

**New York, NY** – Today, Disruption Books announced the publication of *The Green Amendment: Securing Our Right to a Healthy Environment*, a new book by leading environmental activist Maya van Rossum. Unlike its alternatives, this strategy will hold our leaders accountable for defending the inalienable, indefeasible, and inherent rights we all possess as residents of the earth.”

The book is especially timely as new efforts from the Trump Administration threaten to undermine critical and longstanding environmental safeguards like the Clean Water Act. As polluters gain even more power in a legal system that already favors their interests, van Rossum’s campaign illuminates the path forward, showing how the legal system can be reworked to enable people and communities to prevent life-threatening pollution.
