Dear President Elect Joseph Biden,

We, the undersigned 94 organizations, write to ask you to help stop a proposal to build a liquefied natural gas (LNG) export terminal on the Delaware River that poses disastrous environmental and public safety threats for millions of people, including the state of Delaware. The Governors of Delaware, New Jersey, New York, and Pennsylvania and the federal representative from the Army Corps of Engineers are potentially voting tomorrow, December 9, on the permit. We ask you to contact them, the Commissioners of the Delaware River Basin Commission (DRBC), to ask them not to approve this project.

The proposed export terminal would be located in Gibbstown, New Jersey, 6.32 miles upstream from Delaware. The construction and operation of the Gibbstown LNG terminal wharf and infrastructure would increase PCB pollution in the Delaware River Estuary, breaching clean water laws, according to a recent report from the Natural Resources Defense Council. (<a href="https://on.nrdc.org/36WDeTp">https://on.nrdc.org/36WDeTp</a>) The project would not comply with the mandatory PCB discharge requirements under the U.S. Environmental Protection Agency for the estuary, harming water quality, fish and aquatic life and threatening the coastal resources and public safety of downstream Delaware. However, the DRBC, the agency that will vote on the permit, is not adequately considering this issue as it decides tomorrow on whether to approve the terminal.

As President Elect and a former U.S. Senator, we know you are committed to protecting the health and safety of the public and our environment. The Trump Administration has done its best to devastate our clean water laws during his tenure and, through an Executive Order, has pushed this project. A Special Permit was rushed to the owners of this facility to allow for the transport of LNG in rail cars, a practice previously banned by the federal government due to public safety issues. LNG is a highly flammable and potentially explosive cargo that is different from any other hazardous material being transported today. Yet under the special treatment given this company, rail cars designed 50 years ago and never tested for LNG transport will be used to carry LNG from a plant proposed in northcentral Pennsylvania 200 miles to Gibbstown, risking over a million people along the way. In fact, the Attorneys General from 14 states, including all four Delaware River Basin states, have legally challenged a broader federal rule that would allow this transport nationwide. It is imperative to note that population data along the path of the transport routes for the Gibbstown terminal show that black and brown and low-income communities would be exposed to the most intense and inescapable zone of impact should there be an accident such as a derailment. The City of Wilmington has passed a resolution opposing the Gibbstown LNG terminal, citing this environmental injustice. The Gibbstown LNG project is in direct conflict with the philosophy and science-based decisionmaking your administration is proposing under the Biden plan to secure environmental justice and equitable economic opportunity. It is also important to recognize that Delaware has a longstanding ban of LNG facilities in its coastal zone management regulations based on public safety and environmental risks that Delaware considers insurmountable. The climate impacts of the release of methane, the most potent of greenhouse gases, by this project and its supply chain, are enormous. As stated by NRDC regarding the report on LNG

released today, "The recent decision by France to reject U.S. LNG imports demonstrates, these staggering emissions are inconsistent with the recent decisions by China, Japan, South Korea and the European Union to set firm deadlines to become carbon neutral. With the incoming Biden administration making bold commitments to decarbonize, it's imperative that it recognize the peril of LNG, as well." (<a href="https://www.nrdc.org/media/2020/201207">https://www.nrdc.org/media/2020/201207</a>) We know you support the development of clean, renewable energy that will benefit public health, our environment, and our economy by reducing greenhouse gas emissions. We ask that you relay to the DRBC that we cannot allow the greenhouse gas emissions from this project to exacerbate the climate crisis we are facing.

The Delaware River is the water supply for 17 million people, is a Wild and Scenic River and a National Estuary. We ask that you express to the Governors and the Army Corps your opposition to the approval of this project and request that they vote not to approve the terminal - "Dock 2" Docket D-2017-009-2.
